This is in pursuance to CMR's policy (CMR/Pol/HR/POSH/Rev-01/2023) on Prevention of Sexual Harassment at workplace, its Values, Code of Ethics and Conduct. To reinforce our position as an Equal Opportunity Employer considering increasing gender diversity at CMR we would like to inform you of the reconstitution of CMR's Internal Complaints Committee (ICC) for Prevention of Sexual Harassment. The four-member committees are being reconstituted at the Group level and unit level.

Group level Committee will be the higher-level committee to the Unit committees. This committee will meet on need basis to review reported cases of POSH violation, decide on any appeals raised against decision of unit level committee, and monitor adherence to POSH Policy. The Presiding Officer and Every Member of the Internal Committee shall hold office for a period of three only from the date of nomination as may be specified by the employer.
